The Maricopa County Treasurer's Office is dedicated to reducing the cost of government while providing you, the customer, with easy, cost-effective, and convenient services. We have worked hard to make sure that you, the taxpayer, is our first concern. We currently send what is called an "info" card to you with your property tax information on it, even though your taxes are probably paid through your mortgage company. In order to save you, the taxpayer, money we are asking you to sign up for "**eNotices**" so we can send all of your notices and updates to you electronically. Please see enclosed **eNotices** flyer for instructions on how to set up your account access. The **eNoticesOnline.com** authorization code is located in the upper right hand corner of your enclosed tax information statement letter. We will no longer be mailing this info card resulting in a significant savings to you, the taxpayer. This paperless feature is designed to deliver easier, cost-effective, and more convenient services to you. You can always go to treasurer.maricopa.gov, enter your parcel number and get all your tax info directly from the Treasurer's website. I encourage you to view our website at treasurer.maricopa.gov, find your parcel, and explore the online services we provide to make your life easier. Here are some of the exceptional services we offer that you may not know about.

Sign up on-line for eNoticesOnline.com: Sign up and receive all your updates and notices on line.

View and Print Your Bill Online

You can still log on to the Treasurer's website to view or print your tax bill. Get informed, see a breakdown of your property tax and the jurisdictions it supports at treasurer.maricopa.gov.

Secure Online Payments

If your taxes are not paid by a mortgage company, you can save time and pay online. You can pay conveniently by making a payment through the Treasurer's secure website at treasurer.maricopa.gov. We accept all major credit cards and if you pay using an e-Check, the service is absolutely free. You'll receive a confirmation upon payment and a receipt for your records once payment has posted.

Pay Your Property Tax at any Chase Bank

The Maricopa County Treasurer has partnered with Chase bank to make paying your taxes more convenient. Bring your property tax stub to any Arizona Chase bank and pay your property taxes even if you don't have a Chase account. Don't have your property tax stub? Go to treasurer.maricopa.gov, enter your parcel number into Parcel Inquiry and click the 'Go to my Parcel' button. On the Tax Summary page, click the 'Create Stub' link.
